Tuition:

The total cost to educate each child at Maternity of Mary – St. Andrew School during the 2016-2017 school year is approximately \$7,250. This cost is met primarily by tuition, parish subsidy, and fundraising.

Tuition of \$4,150 per child covers 60% of that cost. The remaining cost is covered by:

- Maternity of Mary parishioners contributing \$250,000 per year, which provides \$1,900 per student per year.
- ▶ Fundraising efforts generate \$600 per student per year. (**requires participation by every family**)
- ▶ Other income and donations contribute the remaining \$600 per student.

The early registration fee is \$100 per student and is due at the time of registration. After March 1, a \$150 per student registration fee applies.

TUITION AGREEMENT

You will be contacted via e-mail with a link to set up/update your TADS (our on-line tuition payment program) payment preferences through TADS. Please set up these preferences in a timely manner to ensure the payment plan you desire.

The annual enrollment fee is \$45 for monthly payments. If you choose to pay in one or two installments, there is no annual fee. You will be able to access your statements, tax records, and make payments directly online through TADS.

As an active and involved parent/guardian, I agree to complete and log a minimum of 15 hours of volunteer service to our school during the 2016-2017 school year. These are volunteer hours to be completed by the parents/guardians of the student(s). I understand a completed volunteer log sheet must be turned in by Friday, May 5, 2017.
