



## **Student Pledge for Chromebook Use**

1. I will take care of my Chromebook.
2. I will never leave my Chromebook unattended.
3. I will never lend my Chromebook to other individuals.
4. I will know where my Chromebook is at all times.
5. I will charge my Chromebook's battery each night.
6. I will keep food and beverages away from my Chromebook since they may cause damage to the device.
7. I will not disassemble any part of my Chromebook or attempt any repairs.
8. I will protect my Chromebook by only carrying it while in the case provided.
9. I will use my Chromebook in ways that are appropriate, meet MMSA expectations and are educational.
10. I will not force my Chromebook into an overpacked backpack.
11. I will not place decorations (such as stickers, markers, etc.) on the Chromebook.
12. I will not deface the serial number Chromebook sticker on any Chromebook.
13. I understand that my Chromebook is subject to inspection at any time without notice and remains the property of MMSA.
14. I will follow the policies outlined in the Chromebook Acceptable Use Policy while at school, as well as outside of school.
15. I will be responsible for all damage or loss caused by neglect or abuse.
16. I agree to return the MMSA Chromebook, case and power cords in good working conditions.
17. I will be a proactive digital citizen when using my Chromebook.

## **Student/Parent Pledge for Chromebook Use**

1. I/we understand that Chromebooks are intended solely for educational use and that students are not permitted to download any applications not authorized by their teachers or approved by MMSA administration.
2. I/we understand my/our responsibilities with respect to the care and maintenance of the Chromebook.
3. I/we understand that students will take Chromebooks home in the evenings for school-related use, however, I/we understand that students must have Chromebooks in school every day.
4. I/we understand that students must return Chromebooks at the end of the school year in the condition it was received.
5. I/we understand that I must report any problems or damage to the Chromebook to the principal.
6. I/we understand that MMSA reserves the right to conduct unannounced inspections of student Chromebooks
7. I/we understand that the use of Chromebooks will be governed by all terms and conditions of MMSA policies and regulations, including but not limited to the MMSA Use of Technology Policy.

Individual school Chromebook computers and accessories must be returned to MMSA at the end of each school year or on-demand. Students who withdraw, are suspended or expelled, or terminate enrollment at MMSA for any reason must return their individual school Chromebook computer on the date of termination. Failure to hand in Chromebook and accessories under any of these circumstances will result in the withholding of student transcripts and report cards.
